Capstone: Partnering with patients: Using the triad of nurse, patient, and technology to prevent medication errors. IRB approved quasi experimental mixed method study where nurses were educated to perform medication administration, engaging patients in partnership to look for potential errors. Barcode medication administration data and drug information were verbally shared with patients. Direct observation and patient interviews were performed to see if this intervention influenced identification of potential medication errors.

Clinical Master's Thesis: Nurses' Perception of the Phenomenon of Death. This seven-hospital systematic random nurse survey evaluated what patient situations, or factors in a patient situation, influenced how nurses viewed a patient death from more positive to less positive.
