Narrative Report

Having initially been drawn to medicine following my experience working with the homeless community, I have consistently approached clinical care with an emphasis on treating patients in the context of their individual socioeconomic, psychological, and community infrastructures. This has evolved into my development as an educator and leader. In my current role at Atrius Health, my clinical effort is spent in the ambulatory outpatient primary care setting, where I strive to apply my interests in preventive medicine, women's health, and clinical innovation. This setting allows me to integrate clinical teaching through my roles as a clinical preceptor for HMS and MGH-IHP students, as well as supporting structural efforts to improve primary care training at the resident level. Given my core expertise in procedural medicine, I previously developed a Primary Care Procedure Clinic for MGH, and am currently developing a related structure for Atrius Health.

My primary area of excellence encompasses clinical expertise and innovation, as supported by my longtime involvement with evaluating national healthcare policy as it relates to patient care, and specifically advocating for the ongoing availability of full-spectrum women's healthcare, including abortion services. In addition to procedure clinics, my frequent national and international public speaking engagements on the topics of collaborative leadership and value-based care delivery are informed by my clinical practice, as well as my work with the Harvard Center for Primary Care and the MGH-IHP.

My role as a teacher evolved considerably throughout residency, specifically as chief resident, and now as I have assumed formal roles at the Center for Primary Care and as Medical Director for the PA program at IHP. Serving as core faculty in the Practice of Medicine Course at HMS, I have the privilege of working with our students almost from the beginning of their training in a setting with particular continuity, which, for some of them, extends into their later clinical rotations. I have received recognition from Harvard Medical School, Boston University, Tufts University, the University of Vermont, the University of New England, and MGH-IHP for high-quality clinical teaching of medical and PA students in both inpatient and outpatient settings. I also continually work to integrate my expertise and passions into the Harvard-affiliated residency community, specifically involving the implementation of a women's health curriculum and exposure to procedures for primary care residents, as well as advocating for the establishment of a new family medicine residency.

My dedication to the medical profession and my communities at Atrius Health, MGH, and HMS, coupled with my enthusiasm for improving the delivery of healthcare services and for fostering a supportive, educational environment is clearly reflected in my trajectory as a clinician, leader, and educator. I am constantly seeking to inspire the passions of those around me, and I believe that my strong interpersonal and communication skills have benefitted me as I continue to evolve in these capacities. I intend to further my formal roles as a teacher and leader, and continually seek faculty development opportunities in addition to my clinical duties, as I believe firmly that I can be a positive force in helping others to embrace the inherent sense of purpose that inspires me as a physician, advocate, leader, and educator.
